FINANCE:

CEO REPORT:

- WKO International 2019 to be tied in with North Harbour International likely in March
 - Sponsorship to be secured as \$10,000USD prize money required.
 - TJ meeting with Lodge Real Estate on Friday 27 April
- TJ met with the BNZ Events Manager about 2019 major national events. Discussions held about the potential to lock in the NZ National Championships for three years
- Dominic working on stadium extension plans and front door plans but struggling to get an engineer to complete the plans. Plans to be finalised by mid-June.

- Interclub feedback received and processed into a slightly tweaked format with all ties
 played at Eastlink and Cambridge for B & C Grades and Russ Proctor remaining exactly
 the same.
- P Hanton asked how many clubs had provided feedback. TJ answered that 7 clubs provided feedback.
- TJ gave an update on the Wisden/Slazenger Cup changes and meeting held in Wellington after the AGM with some associations still unhappy about the changes. BNZ has confirmed the contract with Sky TV and will push ahead with the new format with a review to be completed after the first year.
